OFFICIAL RAFFLE RULES

Raffle Summary

- Contest is operated by the Little Red Schoolhouse (LRSH Inc.) under Colorado Raffle License #2026-21357
- “Raffle Sponsor” means the licensee, LRSH Inc.
- Ticket prices: 1 for \$20; 6 for \$100; 10 for \$140; or 20 for \$200.
- There will be TWO winners.
- Prizes: 1st Prize — \$4,000 cash/cashier’s check; 2nd Prize — \$1,500 cash/cashier’s check.
- Prize drawing will be held on Thursday, November 12, 2026, at 7:00 p.m.
- Drawing location: Fatty’s Pizzeria, 106 S. Ridge St., Breckenridge, CO 80424.
- Winners will be posted online within 24 hours at www.littleredbreck.com under this event and will remain posted for 30 days from the drawing.
- You do not need to be present to win. Winners will have 30 days to respond.

Official Rules

1) Each purchaser of a raffle ticket must be at least 18 years old, and only one individual’s name may be associated with each ticket. All federal, state, and local rules shall apply to the raffle. Tickets may be purchased from the website only. Payments for online tickets may only be made by credit or debit card. Any credit or debit card payment that is denied shall disqualify the pending purchase.

2) The Raffle Sponsor, its processing agent, and their respective directors, officers, and members assume no responsibility for incorrect, invalid, terminated, or non-functioning email or mailing addresses, or for lost, incomplete, late, illegible, or undelivered entries or entries without complete, acceptable payment.

3) By submitting an entry, each purchaser acknowledges having read and agreed to abide by these Official Raffle Rules.

4) Once a ticket has been purchased, it is non-refundable except in the event the raffle is canceled in accordance with the raffle regulations of the Colorado Secretary of State. Although a ticket may be transferred, the Raffle Sponsor shall communicate only with the ticket purchaser shown in its records until proof of the ticket transfer is provided to the Raffle Sponsor. Any transferee of a ticket must be eligible under these Rules in order to win. The odds of winning depend on the number of tickets sold and change as additional tickets are purchased.

5) Each ticket shall be uniquely numbered. The raffle period shall begin on the date the first ticket is sold and continue through Thursday, November 12, 2026, at the time of the drawing. Ticket sales will close on Thursday, November 12, 2026, at 6:59 p.m. The drawing will be held on Thursday, November 12, 2026, at 7:00 p.m. Ticket purchase deadlines, drawing dates, times,

and locations may be extended or changed at the Raffle Sponsor's discretion, subject to approval of the Colorado Secretary of State.

6) Each online purchaser will be sent a receipt by email showing a raffle ticket number. The raffle drawing will be held in person on November 12, 2026, at Fatty's Pizzeria, 106 S. Ridge St., Breckenridge, CO 80424. U.S. Postal regulations prohibit the mailing of raffle tickets.

7) The drawing shall take place at Fatty's Pizzeria beginning at 7:00 p.m. on November 12, 2026. The winning raffle tickets shall be chosen at random by selecting "draw" from the raffle site. The winner will have 30 days to respond. The winner need not be present to win.

8) The holders of the winning tickets shall be notified by telephone and online posting, as well as by email from LRSH. The winning ticket number, name of the winner, and the winner's city (but not street address) shall also be placed on the Little Red Schoolhouse website under this event within 24 hours after the drawing. This information may also be publicized in other media. It will remain posted for 30 days from the drawing. Website: www.littleredbreck.com. Questions: 970-453-6871.

9) The winner of the drawing shall be required to provide the Raffle Sponsor with a photo ID, a signed statement confirming eligibility under these Rules and applicable law, proof of age and Social Security number, and a release confirming the Raffle Sponsor's permission to use the winner's name, city, state, and likeness in media releases and other publicity.

10) The winner will be entirely and solely responsible for paying any taxes associated with the winnings and will be provided a W-2G to complete and return to the Little Red Schoolhouse. The winner is advised to consult with their personal tax advisor.

11) The prize will be awarded to the winner once the Little Red Schoolhouse has received both the eligibility agreement and the W-2G. Without tax information, the Little Red Schoolhouse will withhold 24% of the winnings per IRS requirements.

12) Purchasers of tickets, by participating in the raffle, release the Raffle Sponsor, its directors, officers, members, and agents from any and all liability, loss, or claim arising out of any raffle prize, expressly waive any such claim, and agree that the liability, if any, of the Raffle Sponsor, its directors, officers, members, and agents shall be limited to the raffle ticket price paid. In case of any dispute regarding the conduct of the raffle, the decision of the Raffle Sponsor shall be final, only after contacting and conferring with the Secretary of State. All disputes will be handled in accordance with Colorado law.
